I, Pawan Kumar Mahur, Managing Partner of M/s KMPM & Co., Practicing Company Secretaries (FRN: P2020DE081800) have been appointed as a Scrutinizer by the Board of Directors of Shrem Financial Private Limited (acting in its capacity as the Investment Manager of ShremInvIT) to scrutinize the entire voting process i.e. remote e-voting and e-voting at the EGM of the InvIT, in a fair and transparent manner.

 ("LIIPL") as the service provider, for the purpose of extending the facility of remote evoting to the Unitholders to exercise their vote in respect of the resolutions as set out
 in the Notice of EGM from Saturday, April23, 2022 at 10:00 a.m.to Monday April 25,
 2022 till 17:00 hours IST.
- 2. LIIPL had set up electronic voting facility on their websitewww.instavote.linkintime.co.in to facilitate the Unitholders to cast their vote electronically.
- 3. The facility for e-voting through other electronic means was also made available to the Unitholders present at the EGM who had not casted their vote earlier.
- 4. Unitholders holding units either in physical form or in dematerialised form as on Friday, April 18, 2022 i.e. cut-off date, were entitled to cast their vote.

At the end of the remote e-voting period on Monday, April 25, 2022, at 17:00 p.m. the coting portal of LIIPL was blocked forthwith.

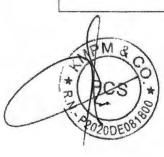

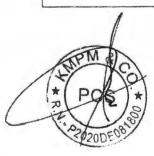
