This is to inform you that the Board Meeting of Shrem Infra Investment Manager Private Limited acting in the capacity of Investment Manager of Shrem InvIT was held today i.e. August 4, 2026, wherein the Board, *inter-alia*, considered and approved the following matters:

1. Unaudited financial statements (standalone and consolidated) of Shrem InvIT for the quarter ended June 30, 2026, along with Limited Review Report of Statutory Auditors. Copy attached
2. Disclosure on the statement of deviation/ variation in utilisation of the fund raised for the quarter ended June 30, 2026 (Nil report). Copy attached as **Annexure A to Unaudited Financial Result**.
3. Declaration of the 21st Distribution, aggregate of Rs. 3.0000/- per unit. The distribution comprises Rs. 0.5469/- per unit as Dividend and Rs. 1.2547/- per unit as Interest and Rs. 1.1984/-per unit as return of capital, subject to applicable taxes, if any.
4. The record date for the purpose of payment of this Distribution is August 7, 2026, and it will be paid to the Unitholders within five working days from the 'record date'.
5. The Valuation Report of Shrem InvIT and its project SPVs for the quarter ended June 30, 2026. The Valuation Report is attached herewith.
